Central Avenue in Kearny to be closed and detoured in both directions Tuesday as Pulaski Skyway Contract 5 advances Central Ave. to be closed again next weekend to complete girder installation under the Skyway

(Trenton) – New Jersey Department of Transportation (NJDOT) officials today announced Central Avenue/CR659 in Kearny will be closed on Tuesday, and again next weekend, for work under the Pulaski Skyway as the rehabilitation of the historic 88-year-old bridge advances. This work was originally scheduled for Saturday, May 9 and postponed due to weather.

Beginning 6 a.m. tomorrow, Tuesday, May 12, until 5 p.m., NJDOT's contractor, Ferreira and Tutor-Perini Joint Venture, is scheduled to close and detour Central Avenue/CR659 in both directions between 2nd Street and 3rd Street in Kearny to erect steel girders under the Pulaski Skyway for the replacement of the Kearny Ramp. These girders will be over Central Avenue. The closure will not effect traffic on the Skyway. Central Avenue is scheduled to be closed again next weekend beginning at 8 p.m. Friday, May 15 until 6 p.m. Sunday, May 17 to complete structural steel work under the Pulaski Skyway. The following detours will be in effect from 6 a.m. to 5 p.m. Tuesday, May 12 and from 8 p.m. Friday, May 15 until 6 p.m. Sunday, May 17:

Central Avenue northbound detour:

- Traffic will be directed to turn left onto 2nd Avenue
- Turn right on Adams Street
- Turn right onto 3rd Avenue
- Turn left onto Central Avenue

Central Avenue Southbound detour:

- Traffic will be directed to turn right onto 3rd Avenue
- Turn left on Adams Street
- Turn left onto 2nd Avenue
- Turn right onto Central Avenue

This work is part of the \$56.2 million Pulaski Skyway Contract 5, which began in April 2018 and will rehabilitate the Kearny ramps to and from the Skyway. The ramps are extensively deteriorated and require deck replacement; superstructure and substructure rehabilitation, strengthening and seismic retrofitting. Contract 5 is scheduled to be completed in the fall of 2020.

Community Outreach

NJDOT created a project-specific website - www.pulaskiskyway.com - which contains a wealth of information about the Skyway and the project, and will be updated with relevant new information as work progresses. The Department is carefully coordinating the Pulaski Skyway project with other regional transportation infrastructure projects to minimize traffic congestion.

NJDOT will be using Variable Message Signs to provide advance notification to motorists of traffic pattern changes associated with the work.
