This letter is in reference to your application for a modification to the above previously approved flood hazard area individual permit. The previous permit was issued for the ongoing construction activities related to the replacement of the Route 7 Bridge over the Hackensack River, the realignment of Fish House Road, and the reconstruction of associated access ramps, and associated stormwater management facilities in the Town of Kearny and City of Jersey City, Hudson County.

The modification hereby approved consists of enlarging the outlet orifice of the detention basin from 3 inches to 15 inches and the installation of a manufactured treatment device certified to 50% TSS removal downstream of the outlet control structure.

The applicant shall affix this revision to the original permit. Please note that all terms and conditions of the original approval are in effect through the life of this permit, and that this revision does not grant any extension to the original expiration date. The drawing approved with this letter shall supersede the approved drawing under the previous permit.
