Dear Ms. Blick:

On July 17, 2014, the Division issued combined flood hazard area and freshwater wetlands individual permit 1600-04-0001.1, which authorized the construction of "...roadway improvements to the merge/interchange of Route 46 and Route 3 and the intersections of Valley Road, Clove Road, Great Notch Road, and Notch Road."

The Department is in receipt of a request to modify the aforementioned permit. The proposed modifications include:

- Relocating the outlet pipe for the sand filter/detention basin (Basin GNR) to discharge to a storm sewer system along Lackawanna Avenue,
- Constructing an additional inlet in order to connect the basin outlet pipe to the Lackawanna Avenue system, and
- Replacing portions of the Lackawanna Avenue storm sewer system.

Upon review of the information submitted with the application, the Department hereby approves the proposed modifications, subject to the following conditions.

1. This authorization shall expire on July 17, 2024, concurrent with the expiration date of the original permit.

2. All conditions in the original permit authorization shall apply to the herein approved permit modification.
3. All sediment barriers and other soil erosion control measures shall be installed prior to commencing any clearing, grading or construction onsite, and shall be maintained in proper working condition throughout the entire duration of the project.

The drawings hereby approved under this permit modification are twelve (12) plans prepared by Stantec Consulting Services, Inc., undated, last revised July 26, 2018, and entitled:


